We have been working hard with our fellow Bay Area NAPABA affiliates (SABA, VABANC, APBA SV, KABANC, and FBANC), with some great results. On the heels of the NAPABA regional conference here in San Francisco, the United States Senate on Monday, June 7, confirmed the Honorable Lucy H. Koh to the United States District Court for the Northern District of California. Judge Koh, an AABA member and long-time AABA supporter, is the first Asian Pacific American federal district court judge in the Northern District of California's 160-year history.

AABA has encouraged Judge Koh's confirmation since President Obama nominated her earlier this year. We have coordinated our efforts with those of the National Asian Pacific American Bar Association, the Asian Pacific Bar of California, and the Asian Pacific Bar Association of Silicon Valley, often relying on those parties to provide progress updates and to convey our encouragement to the Senate. We plan to continue our efforts in urging the confirmations of nominees U.S. Magistrate Judge Ed Chen and Professor Goodwin Liu.

The NAPABA regional conference was spearheaded by the South Asian Bar Association of Northern California, with participation by all local NAPABA affiliates. The conference featured a kickoff judges' reception, with remarks by William Neukom, San Francisco Giants Managing General Partner, a full day of CLE programs featuring our community's finest attorneys, and a lunch keynote by James Potter, Del Monte General Counsel.

We look forward to our ongoing collaboration with other bar associations and community organizations. The events of the past week show that by working together, we can accomplish good things.

TRAVEL – Get out there!

Traveling Notes: The Metric System
