President's Column **Billy Chan**

On Tuesday, July 6, AABA members gathered at the Veterans Equity Center to remember and celebrate the life of Kevin Pimentel, a young AABA member whom we recently lost.

As an immigrants rights and domestic violence attorney at API Legal Outreach, Kevin helped countless clients on everything from family petitions to deportation proceedings. Kevin helped unite families and gave survivors of domestic violence the ability to remain in this country. In his work as a domestic violence attorney, Kevin partnered with advocates from Donaldina Cameron House and Asian Women's Shelter to protect victims from further abuse. He helped survivors escape their situations, stabilize their legal status, obtain custody of their children, divorce their abusive spouses, and begin new lives. As an advocate at the San Francisco District Attorney's victim witness unit, Kevin counseled survivors of abuse about their legal and social service options. His work in the field of immigrants rights and domestic violence made a positive impact on hundreds of families throughout the San Francisco Bay Area.

Kevin worked closely with the Veterans Equity Center to fight for the rights of Filipino veterans. At least twice a month, Kevin would meet with Filipino veterans and their widows and give them free legal advice. In addition, he ran clinics in Daly City and Vallejo, where he gave free legal advice to Filipinos who could not afford representation.

At the memorial, we heard heartwarming stories of Kevin's quirky sense of humor, his loyalty, and his passion for justice. Please take a moment to honor Kevin's life and let's all make a commitment to continue, or support those who continue, Kevin's important work.

The annual event was created in 1988 at the initiative of Bay Area Asian Pacific Islander (API) partners in order to connect law students with the AABA community. Originally organized by the Bay Area API partners themselves, the AABA Employment Committee now organizes this annual event.

Employment Committee Co-Chairs Olivia Lee and Miriam Kim welcomed everyone to the reception. AABA President Billy Chan thanked the sponsors and shared his memory of attending the Summer

Law Clerk Reception as a law student. Robert Uy, Co-Chair of the Community Services Committee, announced the recipients of the AABA Law Student Summer Grants – Stephanie Kang and Gina Szeto. AABA was impressed by both Stephanie's and Gina's dedication to public interest work and the Asian Pacific American Community.

Stephanie Kang, a rising 2L at UC Hastings School of Law, is currently a law clerk with Asian Pacific Islander Legal Outreach (APILO). Her work at APILO involves representing and advocating for survivors of violence; advancing the independence and dignity of older persons by securing legal rights, protections and entitlements; and providing immigration legal services for human trafficking and domestic violence survivors. She has also volunteered with the Asian Law Caucus's Immigration Clinics in San Francisco, and attended



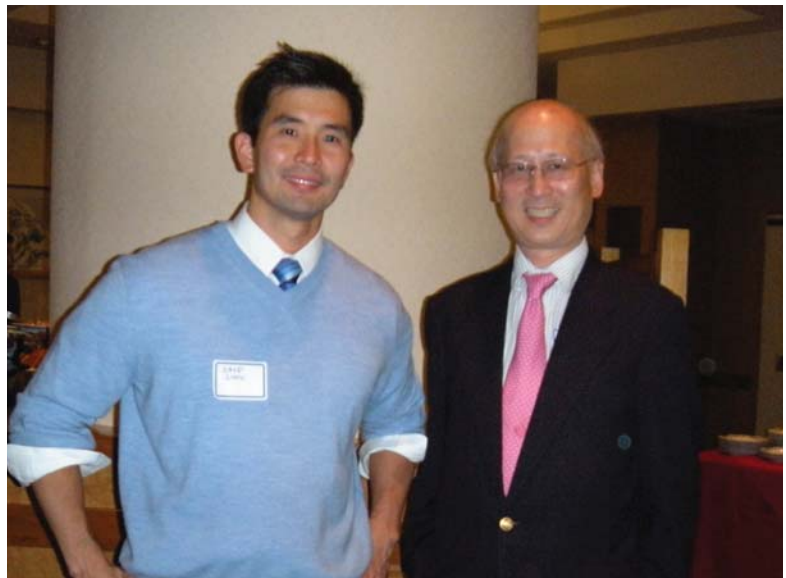

Gina's work with AALDEF's Anti-Trafficking initiative involves the provision of free legal representation to trafficked and exploited women and youth workers. As a rising 2L at UC Berkeley School of Law, Gina will serve as the Director of the Workers' Rights Clinic, Executive Editor of the Asian American Law Journal, as well as Diversity Chair of the Asian Pacific American Law Students Association. Congratulations to both Stephanie and Gina!

Tasty Cultural Experience or E-Coli on a Stick?

The strangest food I'd ever eaten is deep fried garden sparrow in a Beijing alleyway.

Okay, okay, okay. Technically, the strangest foods I'd ever eaten are roasted silkworm, live (still squirming) octopus, cow tongue and cockscomb. But isn't the sparrow the most daring because it was in a Chinese alleyway while I was on vacation? CHINA! Those other foods were just consumed at restaurants in, respectively: Seoul, Incheon, Boston and New York City. Boring. I lived in Korea and grew up back East. Big deal.

Any food cart story from a foreign trip makes the experience seem much more authentic and reveals your culturally sensitive, adventurous side. Plus, it's delicious. Sometimes though, the story ends as a cautionary tale where illness ruined your vacation. When you only have six days to unearth the mysteries of a foreign land, two days of food poisoning is not worth the risk.

But how do you decide?

The CDC's (Center of Disease Control) answer is: "Don't do it." The advice on their website is to avoid street food altogether. It is sound advice, especially when preceded by a list of food borne diseases: Hepatitis A & B, Typhoid, ciguatera poisoning and cholera, to name a few. The best inoculation against the

temptation to eat street food is to visit their website.*

However, multiple AABA members scoffed and without hesitation stated that they always eat street food no matter the destination.

Research reveals that the medical community and the legal community (not including those mentioned above) are united in a more temperate perspective: It depends. In the interests of keeping our members healthy and happy, and therefore more likely to submit vacation photos to the Newsletter, we offer some factors to consider. Remember though: we're not doctors so do your own research before you travel. Oh, and if you do get sick while abroad, skip that story and tell everyone the one about how a state health program provided free medical care and you recovered fully to enjoy the remainder of your trip!

For your consideration: Drink carbonated bottled water or make sure the water was boiled for at least one minute. Consider ice: unless the water in the ice was boiled or from bottled water, it may be contaminated.

Do not eat raw food, including vegetables, fruit or nuts unless

you can peel them yourself (after washing with soap).

Cooked foods should be steaming hot.

The destination: some vendors have access to clean water or operate under a licensing system to ensure quality.

Focus on the ingredients and not the familiarity of the food: a hamburger might have contaminated lettuce while the exotic meal was thoroughly cooked.

Whether the vendor is well established or has a line of healthy customers . . .
