“Sustainable Lawyering” Brings New Hope for Big Firm Lawyers

“Who says being a lawyer has to suck?”

– bold words about big firm law practice from the opening line of a January feature article in San Francisco Magazine. Maybe life at big firms is awful, but help is on the way! A few innovative firms in San Francisco are paving new career pathways for big firm refugees. Some are succeeding in combining big firm perks, including high compensation and sophisticated client work, with work-life balance which the big firms banished with the typewriter.

In 1958, the American Bar Association estimated that “there were only approximately 1,300 fee-earning hours per year”. Hmm . . . are weekends, holidays, vacations, and bio-breaks non-billable? That’s a tough question for many big firm associates in the Bay Area, who may get branded as “slackers” and fall off the partnership track if they can’t hit 2000 billable hours. Attrition rates today at big firms are higher than ever recorded and, according to San Francisco Magazine’s anecdotal reports, higher in the Bay Area than just about any place but New York. Why? A relentless focus on increasing “PPP” (profits per equity partner) continues to increase billable hour pressure and squeeze the life (or at least the few precious remaining hours of non-working, non-sleeping time) out of attorneys. A survey by the Bar Association of San Francisco last year found that the higher a firm’s billable hours per attorney, the higher its associate attrition rate. And for those associates who finish and “win” the multiple year billable hour marathon, the new prize is “non-equity partner”. At some firms, that can seem like a permanent tour as a senior associate. Depressing, huh? The good news is that the chronic suffering of big firm attorneys, as well as their sky-high hourly rates, are creating opportunity for a new breed of firms to emerge

Welcome to the dawn of “sustainable lawyering.” In AABA’s midst, there are at least a few examples of innovative firms which dare to be different while playing in the big leagues. **Silicon Counsel LLP** in San Francisco (www.siliconlaw.com), focuses on business transactions, representing Fortune 500 and emerging companies. By successfully implementing a low-overhead business model with no subsidy of “million dollar senior partners”, its attorneys achieve excellent compensation levels without billable hour requirements or weekend work. The firm’s attorneys share a belief that happier lawyers serve clients better — perhaps reflected in the Client Service Award the firm recently received from CMCP. **Charter Law Group LLP** in Menlo Park (www.charterlawgroup.com), represents a wide range of companies, with a focus on emerging company representation and Asia cross-border transactions. Like Silicon Counsel, the firm is thriving without compromising

work life balance for its attorneys.

Axiom

Legal

(www.axiomlegal.com), an AABA sponsor, has taken the Bay Area by storm after first launching in New York, growing its new San Francisco office in ten months from zero to nearly seventy attorneys. Its unique business model embeds attorneys in the corporate legal departments of Fortune 1000 companies on a temporary basis, giving Axiom attorneys the flexibility to choose clients and projects and be compensated accordingly. The practices of these three firms aim to be sustainable for lawyers and corporate clients alike. By operating with overhead cost-efficiency, they offer billing rates much lower than large firm competitors. *Each is looking for talented attorneys who would welcome freedom from billable hour requirements – see their web sites for more information.* (Full disclosure: I’m the Managing Partner of Silicon Counsel, and the leaders of Charter Law Group and Axiom Legal are my friends).

In addition, solo and boutique practice have long been viable alternatives for big firm attorneys seeking better work-life balance. My fellow Co-Chairs on the AABA Practice Development Committee provide inspiring examples of successful practices which enable their founders to pay Bay Area home mortgages while achieving their career and life objectives. Alex Chiu opened a solo practice in San Francisco, **Law Offices of Alexis S.**

Corporate Leavers Research Initiative

Have you ever thought, "I'm outta here" after some experience in your workplace? Have you left a career in Corporate America or are you thinking about leaving? Level Playing Field Institute is interested in learning why people voluntarily leave corporate jobs, change jobs or change careers altogether. Get a story off your chest. Corporate Leavers is a national study investigating the reasons people voluntarily leave their employers. Hastings Civil Justice Clinic Teaching Fellowship

The Hastings Civil Justice Clinic seeks applications for a new two-year clinical teaching fellowship program. The fellowship is designed for lawyers with preferably at least five years of outstanding legal practice experience, who are interested in preparing for a career in law school clinical teaching. One fellow will be selected for a full-time position beginning June 1, 2007 and ending June 30, 2009.

The Civil Justice Clinic consists of four different clinics with accompanying seminars. The permanent staff includes six full-time clinical faculty members. The clinical fellow's responsibility will be as a co-teacher and supervising attorney in the Individual Representation Clinic. In this one-semester clinic, which is offered each term, students act as lead counsel, under careful faculty supervision, to take cases start-to-finish from the planning of an initial client interview to their culmination in a trial, administrative hearing, or settlement. The Individual Representation Clinic practices in three different subject fields: wage & hour law, social security disability law, and San Francisco rent control law. The other clinics within the Civil Justice Clinic are the Group Advocacy and Systemic Reform Clinic, the Community Economic Development Clinic, and the Mediation Clinic. The Hastings Civil Justice Clinic is widely respected for its high quality representation of clients and its pedagogy, which closely integrates hands-on legal practice experiences and extensive readings, written assignments, and classroom discussions on legal skills development and professional role conceptions.

Hastings College of the Law is part of the University of California. It has a large and vibrant clinical education program that takes advantage of its location in San Francisco's Civic Center and abutting the Tenderloin, a diverse, low-income neighborhood. In addition to the Civil Justice Clinic, Hastings has a separate in-house Refugee and Human Rights Clinic; out-placement clinics in Criminal Practice, Environmental Law, Immigrants' Rights, Local Government Law, Workers' Rights, and State Legislation; an extensive judicial externship program; and a large number of simulation skills courses in negotiation, mediation,

roles and ethics, problem solving and professional judgment, contract drafting, trial advocacy, trial objections, and appellate advocacy. Altogether 19 members of Hastings full-time faculty and numerous adjuncts teach real-client clinics or simulation-based clinical courses.

Fellowship requirements: At least five years of legal experience in client counseling, advocacy, and litigation, as well as experience in or aptitude for supervising and teaching law students (or, if less than five years lawyering experience, exceptional training and experience in supervising or teaching students or other colleagues); California Bar admission; strong written and oral skills; considerable initiative; a collegial disposition; and a demonstrated commitment to public interest or pro bono lawyering.

Fellowship salary and benefits: Salary range of \$50,000 to \$60,000 annually depending on experience; excellent University of California medical, vacation, and other fringe benefits; and full access to all law school facilities.

Application procedure and materials: Please send to Professor Mark Aaronson, the Director of the Hastings Civil Justice Clinic, a cover letter describing your prior legal, teaching, and other relevant experience; your aspirations regarding clinical teaching; and any other information relevant for assessing your potential as a clinical teacher and supervising attorney. In addition, you must include a detailed resume and a sample of your advocacy writing of up to 10 pages.

Dear Governor Schwarzenegger:

Recently, your Appointments Secretary, Mr. Timothy Simon, was the featured guest speaker at the Alameda County Bar Association's (ACBA) Annual Installation dinner. The ACBA was honored that Mr. Simon was able to join us. At the dinner, Mr. Simon announced that Mr. John Davies was resigning as your judicial appointments secretary. On behalf of the East Bay Diversity Bar Coalition (EBDBC), a committee of the ACBA, we are writing to urge you to consider the appointment of a successor who will embrace the diversity of the State's legal profession and strive to create a judiciary that will be truly reflective of the people of the State of California.

Over the last year, much has been written and said about the obvious lack of diversity among recent appointees to the California judiciary. You have this opportunity to select a judicial appointments secretary who will outreach to the many, many lawyers in California who reflect the unique diversity of the State. The EBDBC members include representatives from the diversity bar associations with members in the East Bay and as such, we are aware of many minority applicants who have stellar and outstanding qualifications to serve on the bench. The fact that there are not a hundred such applicants is irrelevant. The only relevant question is—Are there exceptional minority lawyers who have applied for a judicial appointment? And to that, we answer, resoundingly, "YES."

The Judges of this State must herald from many backgrounds and reflect all of the races, ethnicities, cultures and life experiences that make California a "GREAT STATE." The EBDBC and the ACBA urge you to select a judicial appointments secretary that will work tirelessly to fulfill that mandate.

We are looking for attorneys to participate in this worthwhile clinic, which will provide much needed assistance to low-income residents in the San Francisco area. Opportunities Through the BASF Law Academy Mentoring Program

The Law Academy Mentoring Program offers attorneys and professionals in the legal community the opportunity to mentor high school students attending Balboa and Mission High Schools. Mentors are an integral part of the students' education in resume writing, public speaking, interview training, working in a professional environment, and general legal principles. The program culminates with the students interviewing for summer jobs in law offices in the San Francisco vicinity.
