On an entirely different note, many of you may have heard about the murder of Bay Area attorney and 2002 Hastings alumna Xia Zhao in San Jose on July 1, 2008. Her suspected murderer is the defendant in a wrongful death suit in which Ms. Zhao represented the plaintiff. In other words, Ms. Zhao died doing her job – a situation that by and large is unfamiliar to us attorneys, who often occupy rarefied worlds.

Unfortunately, Ms. Zhao did not leave much financial resources to her family. She was in the process of obtaining life insurance when she was killed. Running her own law firm meant she lost money for the first few years. When she died, her law firm had just started to become successful. Her two-year-old son Kael and her aging parents need your help.

Ms. Zhao, a first-generation immigrant and former nurse, was active in an organization called the Chinese American Lawyers of the Bay Area (CALOBA). CALOBA is actively seeking donations to assist Ms. Zhao's son and her parents, whom she supported. I am including a letter from CALOBA in this newsletter regarding Ms. Zhao's life and her work, and how you can donate. In the spirit of generosity and community, I hope you consider assisting Ms. Zhao's family.

Please Help the Family of Xia Zhao

Dear Friends and Colleagues,

Many of you may have already heard about the murder of attorney Xia Zhao (赵霞). The San Jose Police Department presently has a suspect in custody. The suspect was charged but not convicted of killing his wife in 2003. Xia had been representing the late wife's mother in a wrongful death lawsuit against the suspect. It was not Xia's usual practice, but she took this case out of a sense of justice, and to help a grieving mother.



Xia was a first generation immigrant who became a successful attorney with her own practice. She graduated from UCLA and UC Hastings College of the Law, while working night shifts as a nurse to support herself. All those who knew her remember her as a warm, earnest, smart and remarkable lady. In addition to her legal practice, Xia was actively involved in the Bay Area legal and Chinese communities. Xia was the President of CALOBA (Chinese American Lawyers of the Bay Area), an organization of Chinese attorneys in the Bay Area. She is survived by her husband, Kevin Schwarckopf, her two-year-old son Kael, her parents, Mr. Lisheng Zhao and Mrs. Jinfeng Zhu, who are in their 70s, and a brother, Steve. In memory of this dedicated, generous, and courageous woman, a fund has been established for her son and her parents, who, as recent immigrants, were wholly dependent upon her for support. Contributions to this fund may be made by check payable to Xia's Memorial Fund at P.O. Box 10399, San Jose, CA 95130. Alternatively, you can make a donation online to Xia's parents and son through Google Checkout on CALOBA's website at www.caloba.org/xia.html. Please specify whether the donation is for Xia's parents or child.

If you are a lawyer, you understand that Xia died for doing her job. Lawyers being killed for their work are not common. A lawyer should be free to represent clients in difficult or even controversial cases without the danger of being shot and killed in front of her office. To the best of our knowledge, the last it happened in the Bay Area was in the 1980s. Very few lawyers would have prepared financially for such events. After practicing for six years, Xia developed a successful practice but not yet accumulated significant assets due to large expenses that come with running one's own law firm. In addition, unfortunately, the payout from Xia's life insurance is limited and is not enough to provide adequately for her aging parents and child. You would want the legal community and your friends to take care of your family if such tragedy happens. Please donate to help Xia's aging parents and two-year-old son.

If you are not a lawyer, you would want a lawyer willing to represent you in a difficult case without being intimidated, harassed, or even killed. You would want all the lawyers to have the courage to help people when they are in trouble. If you believe in this, please donate to help Xia's aging parents and two-year-old son.

If you are an immigrant like Xia, you understand that her success was built on hard-work, courage, perseverance, and a strong sense of family and community. You would want your community and friends to take care of your family if you encounter any accidents or illness, not only in the event of a tragic killing. If you believe in this, please donate to help Xia's aging parents and two-year-old son. Thank you.

California Supreme Court's Marriage Cases: *Pursuit of Equality*

California Women Lawyers, along with Bay Area Lawyers for Individual Freedom (BALiF), organized an MCLE that featured a screening of Geoff Callan's award-winning documentary "Pursuit of Equality" chronicling the revolution over same-sex marriage in San Francisco, including behind-the-scenes footage of the reflections of Mayor Gavin Newsom and City Attorney Dennis Herrera and the personal experiences of some of the plaintiffs involved in the protest on this historic civil rights issue. (www.pursuitofequality.com). The audience reacted to the touching film with emotional expressions including laughter and tears.

The 90-minute film was followed by a discussion moderated by UC Hastings professor Elizabeth Hillman with panelists Kevin Fong of Pillsbury, who co-wrote and submitted the Asian Pacific American organizations Amici brief in support of the freedom to marry in the California Supreme Court case, and Molly McKay of Gordon & Rees and Media Director of Marriage Equality USA. Kevin inspired the audience with his description of briefing of the case before the California Supreme Court and his collaborating with the organizations who endorsed and signed onto this brief. Molly provided numerous opportunities for people to "get involved" in securing this historic gain through local outreach and educational activities.

AABA Resume Review Workshop Preps Law Students for Upcoming OCI Season

The Employment Committee successfully held the first AABA Resume Review Workshop on July 19th. The Workshop was well attended as law students from eight law schools convened on this Saturday afternoon to meet and discuss with eight volunteer attorneys how to improve their resumes for the upcoming On-Campus Interview (OCI) season.

As many of us attorneys may remember, it is quite competitive to simply be invited for an OCI interview slot, so students must stand out more than ever. The Resume Review Workshop goal was to help students with one of the key tools for securing an interview slot -- a well put together resume. However, because of the unique design of the event, the Workshop gave most students more than just resume tips.

At the Workshop, the eight volunteer attorneys drew upon their own experiences as employers to provide students with tips to effectively convey information that catches the employer's eye. Each student met individually with one of the attorneys in a 30-minute session and also gathered in the main conference room to connect with other students and to ask follow-up questions of the attorneys.

Students like Derek Chien from Santa Clara University took quite a commute to attend the Workshop because he has his eyes on a summer associate position. Like many others, he not only attended the event to receive feedback on his resume, but also to meet AABA attorneys. Indeed, this venue provided a kind of personal interaction between attorneys and students that is difficult to find in our fast-paced profession. David Yoshida, a 2L at University of California, Hastings, found that "the interaction and conversational component is what had a more lasting effect than the review of my resume."

Vinita Kailasanath, a 2L at Stanford Law, expressed similar sentiments. "The event was definitely set up in such a way that provided for a cozy networking atmosphere between the students and attorneys. During the span of about three hours, students from all over the Bay Area were able to mingle and snack on a hearty selection of food."

The Workshop was a success due to the planning and execution of AABA Employment Committee Co-Chairs: Phillip Lee, Elizabeth Loh, Ting-Mao Chao, and Ivana Fedor. Indispensable guidance was provided by AABA Board Member, Isabel Choi, who shared resume and interview guidelines prepared by the USF School of Law's Office of Career Planning. At the event, she addressed numerous inquiries relating to interviewing strategies and the impact of grades on the OCI season.

Many thanks go out to Adeel Akhtar, a partner at Knobbe Martens Olson and Bear, who graciously provided his firm's beautiful 35th floor office in downtown San Francisco to serve as the event venue. The event was a great success as the students tuned up their resumes and received interviewing guidance from the perspective of practicing attorneys.
