LinkedIn ([www.linkedin.com](http://www.linkedin.com)) is a career contacts website with over 17 million users. Users of the website are white-collar professionals including lawyers and business executives. Hundreds of AABA members are also already users. A December 2007 Los Angeles Times article featured LinkedIn as the fastest growing networking site in the world and stated that professionals use it to "expand their professional scope by connecting with college chums, former colleagues and business prospects."

LinkedIn is free to join. Once a member you create a profile that summarizes you and your professional accomplishments. Your profile will help you find and be found by former colleagues, clients, and partners. Celia is a Deputy City Attorney in the San Francisco City Attorney's Office. She is currently assigned to one of that office's prestigious "trial teams" where she focuses on the defense of the City and County of San Francisco and its employees in personal injury, civil rights, and business litigation matters. Celia is a longtime member of AABA having co-chaired AABA's Community Services Committee from 1999 to 2003 and having dutifully served on the Board of Directors since 2001.

**Tell us how excited you are to be the new AABA President?** On a scale of one to ten, my excitement possibly goes to eleven.

On Sunday, January 27, 2008, I had the honor of witnessing Lucy Koh being sworn in as the newest judge in Santa Clara County. Lucy, a former federal prosecutor and most recently a partner at McDermott Will & Emery practicing intellectual property litigation, was appointed to the bench by Governor Schwarzenegger on Friday, January 25, 2008. Lucy, who was one of the "President's Profiles" in this very same AABA newsletter's pages in November 2007, has been a longtime active member of AABA and the Asian American legal community. Most recently, she served as a board member of the Asian Pacific Bar Association of Silicon Valley (APBA-SV). AABA was proud to endorse Lucy for judicial appointment.

Upon taking the oath, Lucy achieved another milestone in her illustrious career: she is the first Korean-American judge in the San Francisco Bay Area. (Another Korean-American judge in Northern California is Sacramento Superior Court Judge Helena Gweon.) Other APA judges in Santa Clara are Judges Erica Yew (who administered the oath to Lucy), Jacqueline Duong, Carrie Zepeda, and Thang Nguyen Barrett.

**In honor of Senior Federal Court Judge Robert M. Takasugi (C.D. Cal) — the first Japanese American appointed to the federal bench - the Takasugi Fellowship will select one of more law students as Takasugi Fellows for the summer of 2008 and fund those fellows' work in an amount up to \$5,000**

A twelve-year old Robert M. Takasugi and his family were uprooted from their home in Tacoma, Washington, relocated and interned along with 130,000 other Japanese Americans pursuant to President Order 9066. Describing the ordeal as “an education to be fair” and one of many challenges he faced, Takasugi went on to receive degrees from UCLA and USC Law School thereafter, his commitment to equal Justice took him to the streets of East Los Angeles, where he represented many indigent arrestees of the Watts Riots, East Los Angeles Riots, and other civil rights protestors in the sixties’.

After serving on the Los Angeles Municipal and Superior Court benches, Judge Takasugi became the first Japanese American appointed to the federal bench in 1976. As both a district court judge for over thirty years and an invitee of the Ninth Circuit Court of Appeals Judge Takasugi’s work has consistently been marked by a high degree of integrity and a commitment to equal access to justice He has been an icon and leader for minority communities for the past forty years.

In 1999, the legal community, including former externs and law clerks of Judge Takasugi, proudly created the Robert M. Takasugi Public Interest Fellowship. The Fellowship was created to honor Judge Takasugi and to perpetuate his influence, independence, courage vision of equal justice and demand that women and minorities be accorded equal treatment. From its inception, the Fellowship has selected fellows from across the nation and funded their summer legal work for the public interest. Fellows were selected to work in the San Francisco Bay Area and the Greater Los Angeles Metropolitan Area and worked in exciting and challenging capacities in forward-thinking organizations, including among others the Asian Law Caucus, the Lawyers Committee for Civil Rights, the Legal Aid Foundation of Los Angeles, and the NAACP Legal Defense Fund Takasugi Fellows have gone on to make substantial contributions to our public interest community. Among its alumni, the Takasugi Fellowship boasts three public defenders (both federal and state) a Stanford Law School professor, and numerous public interest attorneys at non-profit organizations such as the Asian Pacific American Legal Center and the Legal Aid Foundation of Los Angeles.

The honorable tradition of attorneys using the law for the public interest in our communities is fading as taking a nobler path is more financially challenging than ever before. While such work is in itself rewarding, the Robert M. Takasugi Public Interest Fellowship is committed to assisting dedicated law students pursue careers in public interest law.
